1. The number of admissions should not exceed the ceiling specified in column No.5 as prescribed in section 61 of the Karnataka State Universities Act, 2000
2. It is compulsory to meet 08 defined parameters of online affiliation and the college/ Institution should have own land in its name mandatorily.
3. The following defined parameters for online affiliation have not been met. The said defined parameters should be fulfilled in the next two academic sessions, failing which the admissions to the first year degree course will be prohibited. Under such circumstances, permission will be granted to run the college till the second year and third year degree students complete their course. After that the affiliation granted for the college will be cancelled.
