With reference to the above subject, the recommendation of the Local Inquiry Committee at reference (1) has been approved in the meeting of the Academic Council held on 24.01.2025 and in the meeting of syndicate held on 21.01.2025.

Therefore, in terms of section 59(17) of the Karnataka State Universities Act, 2000 the affiliation is continued temporarily for the year 2025-26. Subject to the conditions that imposed by the Local Inquiry Committee are met and defined parameters of online affiliation are implemented and a compliance report along with necessary documents is submitted to the University before 30.07.2025.

CONDITIONS:

- Each and every condition imposed by the Local Enquiry Committee must be complied
 with and a compliance report must be submitted to the University by 30.07.2025.
 Failure to submit a compliance report will result in a fine and disciplinary action as
 per the rules.
- 2. The order and rules of the UGC/State Government and Statutes, Regulations of the University, which are in force shall be strictly followed.
- 3. The student's intake already fixed for the current courses by the University shall not be exceeded at any point of time.
- 4. Admission and other fees shall be collected from the students at the rate fixed by the University and shall be paid to the University by the due date.
- 5. In order to develop the students academically, the academic and teaching system should be improved in the college.

- 6. As per Section 61 of the Karnataka State Universities Act, 2000, no additional admission shall be made beyond the intake limit specified in column 5 above. If the prescribed number of students is exceeded, the University will not approve the additional admissions.
- 7. The college shall make admission to the courses notified as per the University Affiliation order without exceeding the student intake and also not violating eligibility criteria fixed by the University for Admissions to various Courses.
- 8. It is compulsory to meet 08 defined parameters of online affiliation and the college/ Institution should have own land in its name mandatorily.
- 9. The following defined parameters for online affiliation have not been met. The said defined parameters should be fulfilled in the next two academic sessions, failing which the admissions to the first year degree course will be prohibited. Under such circumstances, permission will be granted to run the college till the second year and third year degree students complete their course. After that the affiliation granted for the college will be cancelled.
- 10. The college shall submit application for renewal of affiliations for the Academic Year 2026-27 without fail.
- 11. The college shall obtain accreditation by NAAC after completion of 5 years.
- 12. The principal shall submit the subject wise list of eligible teachers, to the respective Board of Examination Chairperson, without fail.
- 13. If errors are found in the information submitted regarding the incorporation action will be taken under section 63 of the KSU Act.
- 14. The College/Management should not withhold the Marks Cards or any other Academic/Examination related documents of the Candidate beyond 06 (Six) Months or subject to the approval of Admission of the Candidate by the University.
- 15. If any Candidate submit his representation for Transfer Certificate shall be issued forthwith. The College/Management shall only collect the remaining exact Fee of that Semester/Academic Year. It shall not collect any other Fee other than the Fee prescribed by the University.
